Mueller report released unredacted

George Nader, a veteran Middle East policy expert who participated in transition activities for incoming President Donald Trump and later testified in Special Counsel Robert Mueller's investigation into Trump's 2016 campaign, was on Friday sentenced to a decade in prison for possession of child pornography and bringing a minor to the United States for sexual purposes. Nader, 61, received the verdict from Judge Leonie Brinkema in federal court in Alexandria, Va., after an plea deal with federal prosecutors. Read more »
House Intelligence Committee Chairman Adam Schiff will allow President Donald Trump's new intelligence chief to declassify several parts of a Republican-led committee report from 2018 on Russian meddling in the 2016 election. Democrats have derided the report as a whitewash of the episode, arguing that Republicans ended their inquiry without seeking testimony from key witnesses and refusing to subpoena others who would not answer basic questions. But an aide to the Schiff-led committee said Thursday that Schiff will not object to John Ratcliffe's request to view the unreacted report and consider whether more parts can be declassified to the public. Former Deputy Attorney General Rod Rosenstein on Wednesday defended his role in overseeing the federal investigation into Russian meddling in the 2016 election, blaming senior FBI officials for withholding important information related to the probe. The Senate Judiciary Committee hearing came as the panel's chairman, Sen. Lindsey Graham (R-S.C.), is facing increasing pressure from President Donald Trump and his allies to investigate Obama administration officials who led the Russia probe. Democrats, meanwhile, argue that the inquiry -- which appears to be expanding -- is an attempt to drive political interference for the president in the run-up to Election Day. Read more »
Former Deputy Attorney General Rod Rosenstein will testify before the Senate Judiciary Committee next week about the origins of the Russia probe that captured President Donald Trump and his associates for years. The hearing, announced Wednesday by the judiciary Lindsey Graham (R-S.C.), represents an important step in the nascent investigation of the Republican-led panel - one that Trump and his allies have been aggressively encouraging in recent weeks as he seeks retribution on his political enemies. The FBI took steps in early 2017 to end its investigation of former Trump adviser Michael Flynn before he abruptly reversed course, according to new documents filed in Flynn's pending legal attempt to nullify his guilty plea to lie to federal agents. A federal judge has denied Roger Stone's suggestion of a new trial because of alleged inappropriate behavior and prejudice by the chairman of the jury during his trial last year on charges of obstructing congressional and FBI probes into ties between the Trump campaign and Russia. The ruling, which was widely expected, sets in motion a series of events likely to push President Donald Trump to decide in the coming months whether to issue a pardon or commutation that would save his longtime adviser, who is 67, from having to serve the three-year prison sentence he faces. The Justice Department signaled Monday that it could withdraw from plans to put a Russian company on trial next month on a criminal charge that it pounded online and offline troll activity during the 2016 U.S. presidential race. During a court hearing in Washington, a prosecutor questioned whether the firm linked to an ally of Russian President Vladimir Putin - Concord Management and Consulting - was sufficiently involved in the U.S. judicial process to demand a trial on the criminal conspiracy charge brought by Special Counsel Robert Mueller in 2018 as part of a broader indictment of Russian companies and individuals. President Donald Trump's longtime ally Roger Stone, sentenced to 40 months in prison this week for denying congressional investigation into Russia's meddling in the 2016 election, moved Friday to disqualify the judge in his case, arguing that her remarks during sentencing rendered her unable to fairly rule on his bid for a new trial. Stone's lawyers specifically say that Judge Amy Berman Jackson's decision to argue that jurors in the case served with strikes at the heart of Stone's proposal for a new trial, which they indicated is largely based on whether at least one juror was inappropriately biased against him. President Donald Trump threatened Tuesday to file lawsuits everywhere for damages he claims to have incurred as a result of former special counsel Robert Mueller's investigation. In a twitter screed with several posts in the morning, the president denounced the 22-month probe into Russian meddling in the 2016 election and also appeared to weigh back on the federal criminal case against his longtime political adviser Roger Stone. Amid the ongoing turmoil at the Justice Department, a prominent member of former special counsel Robert Mueller's team appeared in a court filing on Wednesday to defend the government's prosecution of former national security adviser Michael Flynn. Just a day after President Donald Trump publicly slammed the targeting of Flynn and longtime Trump adviser Roger Stone, who fueled a furor that apparently prompted four prosecutors to quit Stone's case, Brandon Van Grack delivered a written plea urging a judge to dismiss Flynn's attempt to have his prosecution thrown out because of gross government misconduct. Special Counsel Robert Mueller's prosecutors have never prepared a report to Congress on alleged inappropriate behavior by President Donald Trump. Justice Department lawyers indicated in a court filing Friday. DOJ lawyers said they could not find any records in Mueller's files responding to a freedom of information act request to seek reports and collections prepared for one or more members of Congress' eventual review, regardless of whether such records were actually transferred to any party outside the special counsel's office. Special Counsel Robert Mueller speaks at the Justice Department about the Russia investigation on January 29 (AP file photo/Carolyn Kaster) WASHINGTON (CN) - The Justice Department on Friday published a less-than-edited version of former special counsel Robert Mueller's report, showing that Mueller was considering whether President Donald Trump lied about conversations he had with Roger Stone about WikiLeaks. Many of the details of the recently unseen parts of the blockbuster were first revealed during Stone's criminal case last year, but provide a more complete picture of Mueller's report. The new pieces of the text show Stone telling Trump campaign officials that he was in contact with someone with ties to WikiLeaks and letting the campaign know when he expected the site would release emails that were harmful to the Clinton campaign. After WikiLeaks dropped a tranche of hacked emails from the Democratic National Committee in July 2016, as Stone had predicted in a phone call with then-candidate Donald Trump, the president told Michael Cohen: I guess Roger Correct. But in written responses to Mueller's team, Mr. Trump said he did not remember discussing WikiLeaks with [Stone], nor do I remember being aware that Mr. Stone had discussed WikiLeaks with individuals associated with my campaign. In a previously blacked-out section of volume two of the report, Mueller notes witnesses who told his team that Stone and Trump had talked about WikiLeaks. Citing Trump's public praise for Stone's refusal to testify against him, the report says Trump could have tried to persuade witnesses not to disclose information that would be negative for the president. It is possible that when the President delivered his written answers two years after the relevant events had taken place, he no longer had clear memories of his discussion with Stone or his knowledge of Stone's alleged communications with WikiLeaks, the unreacted version of the paragraph states. But the president's behavior may also be seen as reflecting his awareness that Stone could provide evidence that would run against the president's denials and would link the president to Stone's efforts to reach out to WikiLeaks. Mueller ultimately did not reach a traditional prosecution decision on whether Trump obstructed justice. After using Washington for most of two years, Mueller's report was released to great anticipation in April 2019. The report did not find evidence of a conspiracy between the Trump campaign, although it found that the campaign saw information coming from the Kremlin as useful for its chances in the November election. But even before the Mueller report's formal release, a collection of watchdog groups and media organizations, led by the Electronic Privacy Information Center and BuzzFeed journalist Jason Leopold, filed lawsuits seeking a negligent version of the explosive document. A significant portion of the redactions were related to Stone, a former Trump campaign adviser, who at the time of the report's release faced prosecution for lying to Congress and witness tampering related to the Mueller investigation. The Justice Department was labeled potentially detrimental to an ongoing case, and withheld portions of the report related to Stone while the trial was ongoing. With the trial now finished and Stone facing 40 months behind bars if he is not pardoned, the Justice Department last week said it could re-release the report with fewer redactions related to Stone. In a scathing statement in March, U.S. District Judge Reggie Walton, a George W. Bush appointee, also ordered the Justice Department to hand over a negligent version of the document for its review privately. Private.
